We are pleased to confirm and specify the terms of our engagement with you and to clarify the nature and extent of the services we will provide regarding the preparation of your 2022 income tax returns. This letter and any attachments confirm our understanding of the terms and objectives of our engagement and the nature and limitations of the services we will provide.
